DISTRIBUTION OF VACANCIES FOR RECRUITMENT YEAR 2023

1. Recruitment sanction for the year 2023 has been accorded by the Engineer-in-Chief. The distribution details of Recruitment Sanction for the year 2023 are enclosed as Appx 'C'.
2. The Recruitment Sanction for the year 2023 is forwarded for initiating further action at your end. Recruitment Sanction is based on the wastage vacancies report received from CEs Comd. It is therefore, requested to initiate the process for rect cycle 2023 after receipt of valid NAC.
4. CEs Command are requested to further sub-allocate the vacancies into reservation cat by applying 200 point and 100 point reservation roster and further sub-distribute the vacancies to their lower formations taking into consideration their deficiencies and critical requirements. The distribution of vertical and horizontal reservation against vacancies should be carefully carried out as per latest Govt orders.
5. SOP on procedure to be adopted for Direct recruitment for Gp 'B' (NG), Gp 'C' including erstwhile Gp 'D' categories shall be strictly as per SOP issued by this HQ vide letter No. 85605/Gp 'C' & 'D'/ SOP/CSCC dt 30 May 1997 read in conjunction with letter No. B/20087/LRS/09-10/E1C(1) dt 22 Jun 2011 including all latest Govt orders, RR and amendments issued from time to time on the subject.
6. Chain vacancies of promotions, in chain of hierarchy have been accounted for with the presumption that all the promotional vacancies shall be utilized before direct mode of recruitment, as per respective RRs. In cases, where DR is the last option as per RR, on failure to fill up by specified mode, DR shall be resorted to and ensured that 100% vacancies are utilized within the time frame.

7. The responsibility to issue the appointment letters for various categories of posts as was followed for rect cycles 2015-16 and 2016-17, will be followed for rect cycle 2023 which is as under:-

8. Consequent to this recruitment sanction, following action is required to be taken by concerned authorities:-

(a) DR vac of JE (Civ), JE (E/M), JE (QS&C) shall be passed on to SSC through formal indent by this HQ. Actual Command wise distribution shall be done after receipt of nomination from SSC.

(b) CEs Command will obtain NAC from AG's Branch for DR vacancies of UDC (SAA), LDC (JAA), CMD, MTS & Steno-II. Thereafter, CEs will fwd their indents to E-in-C's Branch for intimating the same to SSC for recruitment.

(c) DCRE vacancies shall be intimated to E1A section for recruitment.

(d) Promotional vacancies shall be intimated to E1 DPC (PP&SUB) for JE (Civ), JE (E/M), JE (QS&C), Supvr B/S and D/Man. Other promotional vacancies shall be filled up by CE Commands.

(e) Compassionate vacancies shall be passed on to E1C (4) section. Its further division for various posts shall be done by E1C(4) section.

9. All CE Command to submit details for NAC as per format in respect of all DR and transfer absorption vacancies of all categories of Gp 'C' post excluding Gp 'B' (NG), i.e JEs, Supvr B/S & D'Man.

10. MoD vide their letter No 17(03) / 2022/D Civ(ii) dt 15 Jul 2022 has issued instruction that vacancies of Draughtsman, Supervisor B/S, Storekeeper, MTS & Mate arise due to retirement, death or otherwise in these cadres/ posts shall not be filled till further orders. Recruitment will be done once the embargo on recruitment is lifted by MoD.

11. **Compassionate vacancies:** The compassionate vacancies to various categories of posts shall be finalized by E1C (4) section of this HQ. While utilizing compassionate vacancies, due priority be given to all the Court decision where consideration was to be given as per Court Judgment.

12. Notwithstanding vacancies arose due to retirement, death and otherwise in following categories shall not be filled up till further orders as communicated vide MoD letter No. 17(03) / 2022/D Civ(ii) dt 15 Jul 2022:-

- (i) Supervisor & Store Officer
- (ii) Draughtsman
- (iii) Store keeper
- (iv) Multi-Tasking Staff (MTS)
- (v) Mate
